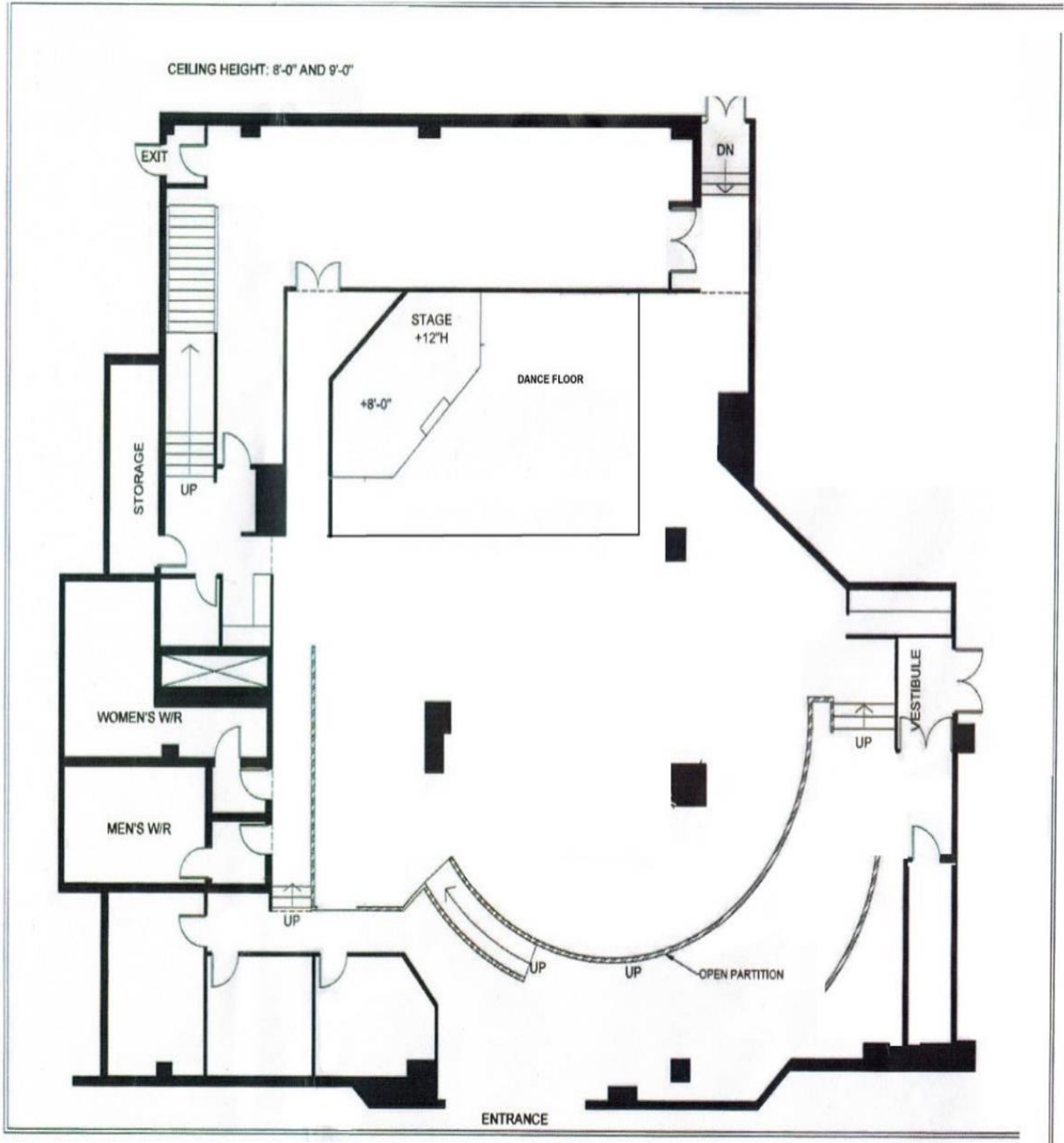

TERMS & CONDITIONS

1. Reservation and Payment

- A **non-refundable reservation fee** is required to secure the banquet space for your event.
- The **final balance** for the event must be paid in full no later than **14 days prior to the event date**.
- Hall rental charges are based on the **number of guests** attending the event, and final pricing will be adjusted accordingly.
- A **mandatory gratuity charge of 13% to 24%** will be added to the total bill, at the discretion of the event.
- A **2% processing fee** will be applied for final payments made via **Visa or Mastercard**, and a **3% processing fee** will apply for payments made via **American Express**.

2. Pre-Event Requirements

- A **mandatory meeting** must take place at the venue no later than **10 days prior to the event date**. During this meeting, the following details must be finalized:
 - Event schedule
 - Meal choices, including any specific dietary requirements
 - AV equipment setup
 - Floor plans and room layout
- All final details, including meal selections and floor plans, must be submitted **10 days prior to the event** during office hours as discussed with the event consultant.

3. Event Changes and Additional Charges

- Belmont Event Space reserves the right to apply a **labor charge** for any **unexpected or last-minute room set-up changes** provided within **24 hours** of the event.
- Any **damage** to the venue or property caused by guests will be the responsibility of the client. The client will be charged for the full cost of repairs or replacement.

4. Cancellation Policy

- **Cancellations** made within **14 working days** of the event date will result in a penalty fee of **50%** of the total estimated bill, including food, beverages, and room rental charges.

5. Security and Liability

- Belmont Event Space is **not responsible for any lost or stolen articles**. The client is advised to take all necessary precautions to secure their personal property during the event.
- Belmont Event Space is **not responsible for the reception, storage, or return shipment** of any materials, decor, or personal items before, during, or after the event.
- The client is solely responsible for ensuring that **adequate measures** are taken to protect their property during the event.

6. Force Majeure

- Belmont Event Space shall not be held liable for any delay or failure to perform due to events beyond its control, including but not limited to, natural disasters, government regulations, acts of terrorism, strikes, or other unforeseen circumstances that may prevent the event from taking place.

7. Indemnification

- The client agrees to indemnify and hold harmless Belmont Event Space, its employees, agents, and contractors from all claims, damages, or losses arising out of the client's use of the venue, including any acts or omissions of the client or their guests.

8. Compliance with Laws

- The client agrees to comply with all local, state, and federal laws and regulations while using the venue. This includes, but is not limited to, fire safety regulations, alcohol consumption, and noise ordinances.

9. Alcohol and Catering

- The consumption of alcohol is subject to local laws and regulations. **Outside alcohol** is not permitted without prior approval and may incur an additional fee.
- All **food and beverage services** must be provided exclusively by Belmont Event Space or a licensed caterer authorized by the venue. If the client wishes to bring their own food or beverage, Belmont Event Space will **not be held responsible** for any issues that may arise, including but not limited to, food quality, safety, or allergens.
- Belmont Event Space **will not be responsible** for any health issues, allergic reactions, or food-related illnesses that may arise from the consumption of food or beverages provided by the venue or from outside, including those related to allergens such as gluten, nuts, dairy, etc. By signing this agreement, the client acknowledges and agrees that they are fully aware of the potential risks associated with allergens and food sensitivities.
- **Leftovers:** While we do not encourage guests to take food home, if any leftovers are taken, the client assumes full responsibility. Belmont Event Space will **not be liable** for any health issues or allergic reactions that may occur after the event, including issues related to the consumption of leftover food or drinks.

11. Health and Safety

- The client agrees to adhere to all health and safety guidelines in place at the time of the event, including any restrictions related to **COVID-19** or other public health concerns. Belmont Event Space reserves the right to modify policies as needed to ensure the safety of all attendees.

12. Miscellaneous

- This agreement constitutes the **entire contract** between the client and Belmont Event Space. Any modifications or amendments to this contract must be made in writing and signed by both parties.
- If any provision of this agreement is determined to be unenforceable, the remainder of the agreement will remain in effect.

13. Governing Law

- This contract shall be governed by and construed in accordance with the laws of the jurisdiction in which Belmont Event Space is located.
